You have been reading about it in every newsletter this year but this is a very important announcement for those of you thinking about upgrading your agency with a new computer system. The deadline for agencies to receive their purchase tax-free is December 31st, 2023. If you are going to purchase new computer equipment before the deadline you will find the exemption form on the Department of Revenue website or reach out to Tom at the association for a copy.

Insurance Day on the Hill

As you are aware, the Big "I" was unable to participate in the 2023 Insurance Day on the Hill due to a scheduling conflict with our Rural Agents Convention. In spite of that conflict, a group of independent agents from across the state made our way to the State Capitol on February 21st and met with all of our legislative leaders. The group had great discussions on issues important to all of us and we appreciate all those

who participated in the event. We are back on schedule for our normal insurance day on the hill next year on February 21st, 2024.

Agency E&O Market Consistency

The professional liability marketplace is ever changing. Carriers enter and exit the marketplace, change rates, and shift their underwriting appetites and priorities. Inflation, reinsurance capacity and carrier financial strength also factor into an errors & omissions carrier's consistency.

Typically, the longer a carrier has been in the professional liability marketplace, the more stable it is when it comes to rates, coverage and deductible requirements. Without longevity in the marketplace, the deductible waiver features could be meaningless.
